There are three main areas to clean growth:

- I. First, it's the UK government's strategy for boosting our economy while reducing gas emissions and protecting the environment.
- 2. Second, it will achieve this through encouraging the creation and production of innovative goods, services and technologies.
- 3. And, third, it is here to help UK businesses of all sizes, through the Department for International Trade (DIT), to export their goods and services.

The ambition is for clean growth to help deliver a Green Industrial Revolution, as set out in the Government's Ten Point Plan.

CASE STUDY

Ansaldo Nuclear Ltd specialises in the design, manufacture, assembly, test, installation and commissioning of customised solutions for the nuclear decommissioning, defence, and nuclear new build markets.

Ansaldo first engaged with The Department for International Trade back in 2018. They have been on a range of events, and tradeshows and showcases. In the last few months they have actively engaged with the ITA and Clean Growth Adviser to proactively raise the Ansaldo profile to support their growth plans to build the business at the Wolverhampton site and increase employment by 100 in the next year.

Currently their local ITA is working with the team to build relationships with DIT Nuclear Sector Specialists and overseas consulate colleagues already achieving successful and informative discussions with Specialist Advisers in France, Germany, Finland, Japan and Lithuania. From these discussions they have secured details from the Finnish energy company Fennovoima constructing Hanhikivi I nuclear power plant at Pyhäjoki, SMR information on new builds for Fortum and the tender documents for the Ignalina project in Lithuania. There are also potential opportunities in the ITER project as well as potentials in the Hydrogen market sector.
